



**2012 Presidential Classic**  
**APPROVED VACATION HOME / CONDO HOUSING OPTION**  
**DIRECT CALL PROGRAM AND PROCEDURE**

**Purpose:**

This procedure is established as a variation to the standard Event Housing Policy. This option will give team/gyms the ability to work directly with an approved event vacation home/Condo supplier and utilize the selected accommodations as their primary team/gym lodging during the **2012 Presidential Classic** event. This program allows team/gyms the individual flexibility of maintaining control of important housing selection criteria (location, cost, amenities, etc) while still following the parameters of the “Rooms To Compete” program format.

**Procedure:**

Please review the steps below to chose and finalize your desired accommodations. Once your housing arrangements are complete, fill out this form with the requested information then mail or fax to the GET Travel Corporate Office. Once received and reviewed; GET Travel will approve your team/gym as compliant with the housing policy.

**Step 1** Choose one of the approved vacation resort management companies listed below and call or email them to discuss your housing needs, pricing and rental terms. You can work with one or more of the approved companies to select the home/condo that meets your team/gym’s specific housing requirements. Booking the company directly online through any source **DOES NOT** apply in this program. The procedure is to state up-front to the selected company that you are a preferred GET Travel Sports Traveler and give them our specific Event ID Code of: “GET-PRES CLASSIC”.

You will receive a return “housing policy compliance” confirmation within 48 hours.

**Reservation and Cancellation Disclaimer:**

By choosing this Vacation Home / Condo Direct Housing Program, your team/gym has opted to work direct with one or more of the approved housing management companies. By completing the above steps, your team/gym is provisionally approved to make reservations outside of the official hotel program. However, In the event your team/gym cancels the reservation and the reservation is not re-booked with one of the approved vacation home management companies nor re-booked utilizing one of the GET Travel Disney or Disney Good Neighbor Hotels, your team/gym will no longer be considered compliant. The team/gym will subsequently be required to pay the \$300 Housing Policy Buy Out fee to stay registered in the tournament. Any team/gym(s) not compliant with the “stay-to-play” policy or not paying the “Buy-out” fee will be withdrawn from the event schedule until the housing policy is satisfied. Reservations shall be re-confirmed at any time prior to event start date by GET Travel, including the day your reservation begins. Furthermore, your signature below is acknowledgment and your acceptance of the Housing Policy Waiver option and you accept full responsibility of your group’s vacation/condo lodging experience.
